*The Misty River Hounds Summer Trailride* is a trail ride ridden at your own pace. A self-guiding map of the trail will be given to each rider or group of riders at registration. The trailride is designed for riders to enjoy a wonderful day on your favorite horse riding over beautiful terrain with friends and family. Jumps between 18" and 3' are available for those wishing to school them. Riders can begin riding out at 9:30 A.M.

**What to Wear** Casual riding attire. Protective head gear is recommended. Western riders are welcome!

#### **Entry Fee**

- \* \$15 per rider for entries postmarked by June 15th/ \$20 per rider for late entries and at the gate
- \* Riders under 16 must be accompanied by an adult
- \* If the event is canceled due to foul weather, entries will be refunded
- \* Proof of negative Coggins dated within 12 months will be checked at the gate

**Lunch** A delicious bar-b-que lunch will be available after the ride. Bring a covered dish to share at the bar-b-que and bring your own beverage of choice.

**Swimming** Bring your bathing suit if you want to take a dip in the cool waters of Big Eddy after your ride

**Directions** From Fayetteville- Take Hwy 45 east to Hwy 412 E. After passing three Huntsville exits, turn left on County Road 1648 (across the road from Ma & Pa's Dent and Bent). Turn left on county Road 1335. Go one mile until you see the hayfield and the red barns. Lost? Call 479-601-3118.
